Eugene B. Boston of Pittsgrove passed away on January 7, 2015 in Cooper Hospital, Camden, with his loving family present. He was born March 4, 1935 in Pittsgrove and graduated from Vineland High School in 1953. Mr. Boston was president of Phil Desiere Electric Motor Service, Inc.
