A devoted husband, father and friend, Thomas Crim, 42, of Elmer died on Wednesday, November 15, 2006 surrounded by his family and friends. Born and raised in Elmer, Tom was the son of Herman and Sandra (nee: Bell) Crim. Tom currently worked for the New Jersey State Forrest Fire Service. In fact, it was in 1982 when Tom first started volunteering for both the Elmer Fire Department and the Elmer Ambulance Corps.
